



## **2024 SCHEDULE OF MEMBERSHIP DUES, FEES AND OTHER CHARGES**

**REVISION 09.12.2024**

The following is a detailed outline of the 2024 Membership Dues, Fees, and Other Charges which should be reviewed with all documents included in this package.

### **1. MEMBERSHIP DUES**

Membership runs from May 1, 2024, to October 31, 2024. Members have the option of paying their Membership Dues at discounted rates prior to November 15, 2023 (see attached Schedule of Dues for details). The 2024 "In Season" rate takes effect on November 16, 2023. All Membership Dues are stated on an annual basis. Members wanting to register for any in-house events will have to pay in full by March 15<sup>th</sup>, 2024. Members not returning or indicating their intentions by January 15<sup>th</sup> will be deemed to have resigned. Membership changes will be prorated on a biannual basis only. Members are responsible for keeping their membership in active status. No reminders will be issued in advance of these dates. For renewing members with outstanding entrance fees, these fees are due on the date of renewing.

Should a membership category change be necessary, please advise the Administration Office in writing. Club Administration will promptly make any refund, which occurs from an overpayment, following a membership category change. No membership downgrades will be accepted after March 15, 2024.

Should any Member have specific questions regarding membership categories and options, our Administrative Staff will be delighted to help.

The following Mandatory Fees are **NOT included** in the Membership Dues Total, and will be billed separately:

#### **GOLF ASSOCIATION DUES**

Golf Association Dues of \$42.00 + HST will be charged to all golfing Members including Intermediate and junior members, based on the rate set by the respective Associations. Vespra Hills Golf Club belongs to the Golf Association of Ontario (GAO) and Golf Canada.

### **HOLE-IN-ONE FEE:**

A Hole-In-One Fee of \$10.00 per member, except for Junior Associate Members, is placed into a fund to be used for a complimentary beverage for your foursome when a member makes a Hole-In-One at Vespra Hills. The foursome will be invited to a year-end dinner.

This charge may be applied additionally during the year depending on the number of Holes-in-One made throughout the season. Complimentary beverages are not supplied if a Hole-in-One is made by a non-member or by a member in a fund-exempt category.

### **EVENT PRIZE FEE:**

A Prize Fee of \$20.00 per member, except Junior Associate Members, is placed into a fund to be used to help fund prizing and trophies of club events.

## **2. OTHER FEES AND CHARGES**

### **LOCKER RENTAL**

The renting of a Locker is an optional service. Members who have previously held a locker will be billed automatically for a locker in 2024 unless they advise the Administration Office in writing of their wish to cease rental privileges. The Locker Rental Fee will be eliminated, or refunded if previously charged. Any lockers not confirmed by January 15, 2024, will be released for rental. Lockers are not available to Juniors, Social Golf, or Social Dining Members.

The Locker Rental Fees for the season are as follows:

2ft Cube Locker - \$70.00, "Z" Locker - \$110.00, Full Locker - \$175.00

All Locker Rentals are subject to HST

Member requests for Lockers can be made to the Administration Office, with Members being given priority on a first-come, first-served basis.

## **CLUB STORAGE**

Club Storage is an optional service. Members have the option to leave their clubs at Vespra Hills Golf Club. This convenient service allows members to arrive at Vespra Hills with their clubs already on a cart or out front, clean and ready for play. The charge for Club Storage bag only is \$200.00 + HST and Club Storage with push or powered push carts is \$300.00 + HST. Club storage is not available to Social Golf or Social Dining Members. Juniors will be based on availability.

Member requests for Club Storage can be made at the Administration Office, with Members being given priority on a first-come, first-served basis.

## **CART PROGRAM**

Members have the option to sign up for a seasonal cart package. This is a pre-paid half cart. Riders other than members who have a pre-paid cart package will be charged applicable cart rental fees. This cart package is not transferable and may not be used for guests or other playing partners. Payment of a cart package plus HST can be included in your 2024 dues. The seasonal cart package expires on October 31<sup>st</sup>, 2024.

Vespra Hills Golf Club does not guarantee cart availability.

## **4. PAYMENT OF ACCOUNTS**

All Members, Intermediate and junior Associate Members as well as Social Golf and Social Dining Members are required to have and maintain a "Member Account". Day-to-day purchases by Members or Guests of Members for goods and services at Vespra Hills Golf Club may be made by charging to the Member's Account. Vespra Hills Golf Club does not accept cash for day-to-day purchases however cash, credit card, debit card, or cheque may be used for payment of Members Accounts. Members' Monthly Statements are available for viewing online through the Club's Tee-On website. A link can be found at [www.vesprahillsgolfclub.com](http://www.vesprahillsgolfclub.com). Members may contact the Administration Office for personalized instructions for accessing their Monthly Statements online. It is the member's responsibility to keep their payment information up to date. A \$50.00 fee will be charged for NSF and or declined account payments.

## **5. OVERDUE ACCOUNTS**

Statements are rendered on the 15<sup>th</sup> and 30<sup>th</sup> of each month with accounts being due and payable. Members in arrears will be charged a \$50.00 fee and have their playing privileges **immediately** suspended until their account is cleared. The Club's policy regarding members' accounts in arrears still applies to these accounts. Members may ultimately face expulsion from the Club for non-payment of their account or tabs.
