



## **GOLF MEMBERSHIPS 2023**

(Age is determined by the Member's age as of May 1<sup>st</sup>, 2023).

### **VESPRA HILLS OFFERS THE FOLLOWING MEMBERSHIP CATEGORIES:**

**\*In addition to the specific category descriptions, the following four golf memberships include: Permission to entertain guests under the Club's usual guest playing privileges: Online tee time booking access: Unlimited use of the Clubs practice facilities and full access to the Club's dining areas.**

#### **SEVEN DAY GOLF MEMBER**

This is an unlimited seven days a week play with no restrictions and seven day booking privileges.

#### **SPOUSAL MEMBERSHIP**

Membership includes couples, married or legally recognized as a common-law couple and who reside at the same physical address. Couples are required to provide proof of residency by submitting an identification document such as a valid Driver's License at the time of application. The Management reserves the right to review each application and to waive the previous requirement in unique circumstances. This is an unlimited seven days a week membership with no playing restrictions and seven day booking privileges.

#### **WEEKDAY GOLF MEMBER**

This Membership is an unlimited weekday play with five day booking privileges. Game fees apply for weekend play. Weekday Members may play golf on Statutory Holidays after 2:00 PM with their game fee waived. Any golf played prior to 2:00 PM on Statutory Holidays will be subject to the applicable game fee.

## **A LA CARTE GOLF MEMBER**

This is an unlimited seven days a week play with no restrictions and five-day booking privileges. This membership includes ten 18-hole rounds of golf. These games may be used as up to twenty 9-hole rounds. Game fees apply for additional rounds played

## **VESPRA HILLS OFFERS THE FOLLOWING ASSOCIATE MEMBERSHIP CATEGORIES:**

### **INTERMEDIATE MEMBERSHIPS**

**\*Intermediate I, II, III & IV associate members enjoy full unlimited seven days a week play with no restrictions, three day booking privileges, unlimited use of the Club's practice facilities and full access to the dining areas.**

**\*Membership Dues for all Intermediate Associate Memberships are staggered, increasing from 19 through 33 years of age. Intermediate Associate Members are permitted to entertain guests under the Club's usual guest play privileges. All Intermediate Associate Memberships must have a full golfing membership associated with them.**

### **INTERMEDIATE I ASSOCIATE MEMBER (19-21)**

Intermediate I associate members must have attained the age of nineteen (19) years, but not yet twenty-two (22). Vespra Hills Golf Club will apply \$150 towards entrance fees for each consecutive year that an Intermediate is an associate member.

### **INTERMEDIATE II ASSOCIATE MEMBER (22-24)**

Intermediate II associate members must have attained the age of twenty-two (22) years, but not yet twenty-five (25).

Vespra Hills Golf Club will apply \$150 towards entrance fees for each consecutive year that an Intermediate is an associate member.

### **INTERMEDIATE III ASSOCIATE MEMBER (25-29)**

Intermediate III associate members must have attained the age of twenty-five (25) years, but not yet thirty (30).

Vespra Hills Golf Club will apply \$150.00 towards entrance fees for each consecutive year that an Intermediate is an associate member.

### **INTERMEDIATE IV ASSOCIATE MEMBER (30-33)**

Intermediate IV associate members must have attained the age of thirty (30) years, but not yet thirty-four (34).

Vespra Hills Golf Club will apply \$250.00 towards entrance fees for each consecutive year that an Intermediate is an associate member.

### **JUNIOR MEMBERSHIPS**

**All Junior Memberships must have a full golfing membership associated with them and may only entertain Junior guests. Junior Members have two day booking privileges and may not book online. Juniors may not operate a power cart, including those who may have their driver's license.**

### **JUNIOR I ASSOCIATE MEMBER (9-11)**

Juniors who have attained the age of nine (9) years, but not yet twelve (12), are restricted on weekdays to playing after 8 a.m. and from 1:30 p.m. on weekends and holidays. Junior I associate members are not permitted to play or use the practice facilities unless supervised by an adult. The Junior I associate golf membership includes, unlimited use of the Club's Practice Facilities.

### **JUNIOR II ASSOCIATE MEMBER (12-15)**

Juniors who have attained the age of twelve (12) years, but not yet sixteen (16), are restricted on weekdays to playing after 8 a.m. and from 1:30 p.m. on weekends and holidays. Junior II associate members *must pass an annual etiquette test with Vespra Hills Professional Staff before being allowed to play or use the practice facilities unattended.* The Junior II associate membership includes, unlimited use of the Club's Practice Facilities.

### **JUNIOR III ASSOCIATE MEMBER (16-18)**

Juniors who have attained the age of sixteen (16) years, but not yet nineteen (19), are restricted on weekdays to playing after 8 a.m. and from 1:30 p.m. on weekends and holidays. Junior III associate members may play the golf course and use the practice facilities unattended. The Junior III associate membership includes, unlimited use of the Club's Practice Facilities.

### **SOCIAL DINING MEMBERSHIPS**

**Social Dining Members** have a member account and full access to the Club's dining areas for regular and special event business. Members in this category may play golf at the Club, as a guest of an active Golfing Member, in accordance with the Club's Guest Policy. Social Dining Members are not eligible to play in Club events. A Social Dining Membership provides Clubhouse access for one person. Their spouse or guests are welcome to enjoy the food and beverage services of the Club, but only in the presence of the Social Dining Member.

### **SENIOR MEMBERSHIP TRANSFER**

Members that are over 70 years may transfer their membership to a child or grandchild if they have paid their entry fees in full and have been golfing members in good standing for five consecutive years. Playing privileges are maintained upon payment of applicable Annual Dues. Transfer fees will apply.
